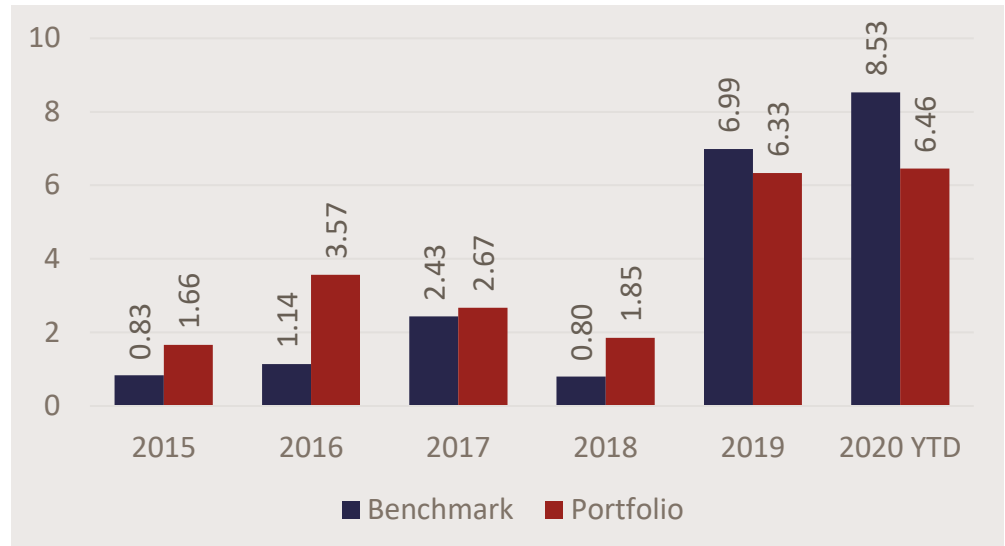

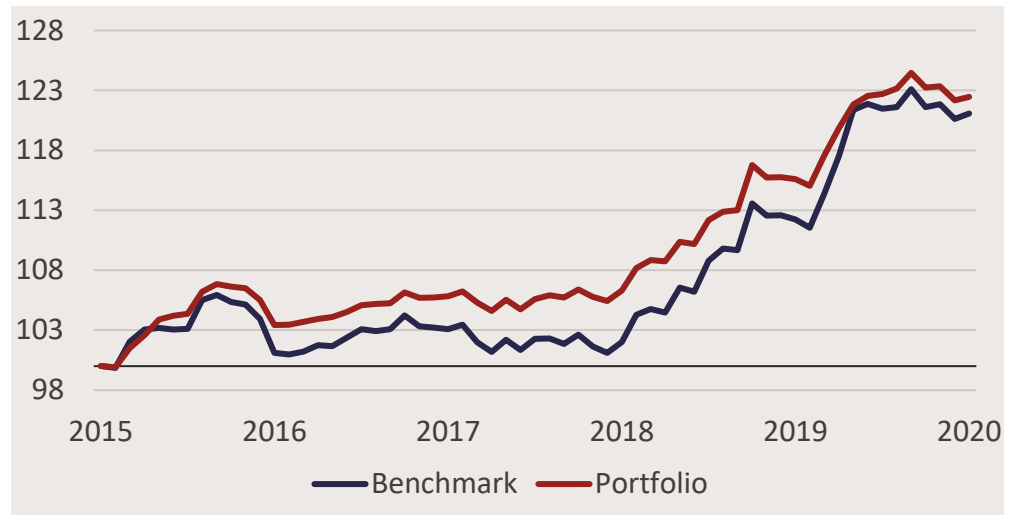

### Annual Performance %



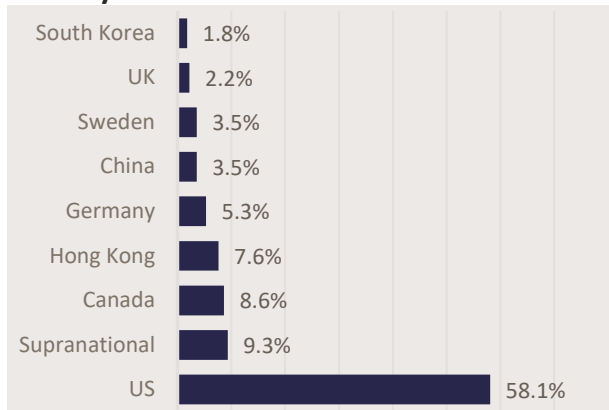
### 5 Year Cumulative

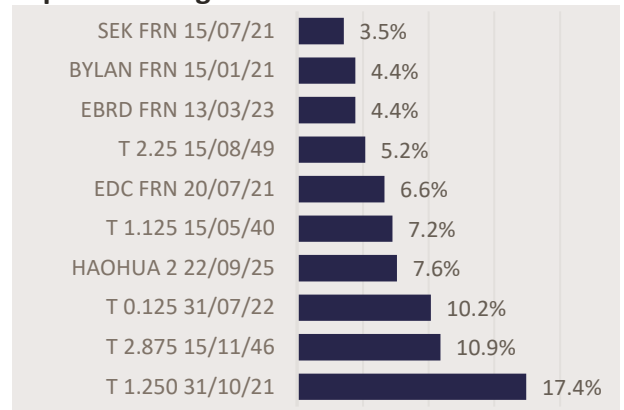

**Top 10 Holdings**



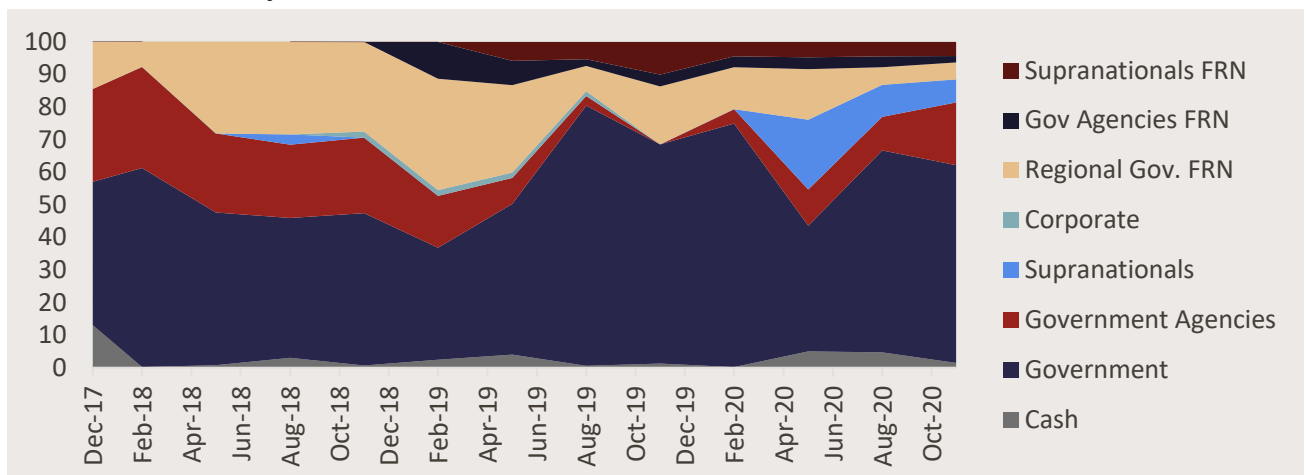
**Investment Objective**

The Portfolio pursues its investment objective by investing in a broad range of U.S. dollar-denominated floating rate or fixed income instruments issued or guaranteed by entities whose minimum credit rating (at the time of purchase) is BBB- by Standard & Poor’s or its equivalent. The Portfolio invests, in normal circumstances, up to 50% of its value in the supranational and sovereign agency issuers. The Portfolio may invest in corporate securities, with a maximum limit set at 30% of its value with no single investment exceeding 5% of the Portfolio’s value. The Portfolio may also seek to obtain exposure in non-US Dollar denominated securities, subject to the above-mentioned concentration limits, with no more than 20% aggregated open FX exposure at any time.

In pursuing the Portfolio’s investment objective, CAIMS’s investment team will seek to enhance the Portfolio’s return via active management and managing overall volatility of returns. The investment philosophy is based on relative value analysis aiming to identify and select those instruments which offer attractive risk /return profiles to other similar securities, consistent with the Portfolio’s investment targets.

The Portfolio will also take active duration positions vs. its benchmark. The Portfolio’s benchmark is the ICE BofA US Treasury Index.
